## Fire Training Academy Marine Firefighting Open Enrollment Courses

### Basic Marine Firefighting Open Enrollment

2 Days/17½ Hours – Course Number WSPFTA-53

This 17.5-hour course aims to provide the training for candidates in fire prevention and firefighting in accordance with the 1995 STCW Convention Chapter VI, Section A-VI/1, paragraph 2 and Table A-VI/1-2. On meeting the minimum standard of competence in fire prevention and firefighting, the trainee will be competent to take appropriate measures for the safety of personnel and of the ship along with using fire appliances correctly. The trainee will also have knowledge of fire prevention.

### Advanced Marine Firefighting Open Enrollment

4 Days/32 Hours – Course Number WSPFTA-15

This 32-hour course is designed for all seafarers with safety or pollution prevention duties. This course covers the training required by STCW Section A-VI/3, as outlined in Table A-VI/3, Annex Two of the International Maritime Organizations (IMO) Resolution A.437 (XI) "Training of Crews in Firefighting" and the Code of Federal Regulations (CFR).

### Advanced Refresher

#### Marine Firefighting Open Enrollment

2 Days/16 Hours – Course Number WSPFTA-697

This course consists of both classroom and field training that covers the requirements of the 1995 STCW Convention Chapter VI, Section A-VI/3 and Table A-VI/3. On meeting the minimum standard of competence in advanced firefighting, a trainee will be competent to take command, organize and train fire parties and control firefighting operations. The seafarer will have acquired knowledge of fire prevention and an ability to inspect and service fire detection and extinguishing systems and equipment. They will also be able to investigate and report on incidents involving fire. This course is meant for mariners who do not have 1 year of seagoing service in the previous 5 years prior to the start of the course.

### Advanced Revalidation

#### Marine Firefighting Open Enrollment

1 Day/8 Hours – Course Number WSPFTA-777

This course has no classroom training and is field based training only. It covers the same training as the "Advanced Refresher" course (see the above course description for details). This course is meant for mariners who have 1 year of seagoing service in the previous 5 years prior to the start of the course.
