## 2022 WEEKEND RECRUIT ACADEMY

298 HOURS

This course will prepare the entry-level firefighter to meet Washington State certifications for Fire Fighter I and Hazardous Materials Awareness/Operations.

### PREREQUISITES & REQUIRED ITEMS:

- The Recruit has completed and passed a physical examination conducted by a licensed medical doctor using either:
  - National Fire Protection Association Standard 1582, and/or
  - The medical standards of your organization
- A physician or other licensed health care professional has approved the Recruit to work using a self-contained breathing apparatus
- The Recruit has undergone a Respirator Face Piece fit test that meets the requirements of WAC 196-262-07150
- The Recruit is 18 years of age at the start of class
- The Recruit has medical insurance coverage
- The Recruit has valid CPR and First Aid certifications
- The Recruit has passed your fire department's physical agility test or has completed a Comprehensive Physical Assessment Test (CPAT) within one year
- The Recruit has a valid driver's license
- The Recruit is affiliated with a Fire Department
