Certifies this service center has been examined and meets all requirements as outlined in [chapter 204-50](#) of the Washington Administrative Code (WAC) and is ready for inspection by the Washington State Patrol (WSP).

- The service center is located in a facility which properly accommodates installation, inspection, downloading, calibration, repair, monitoring, maintaining, servicing, and removal of interlock devices.
- The facility complies with all municipal and/or county zoning regulations for commercial businesses and a corresponding business license has been issued, is current, and available for inspection.
- The facility has a designed waiting area that is separate from the installation area. The designed waiting area is shielded from the installation area so a lessee or any other unauthorized person is unable to witness the installation or service of the ignition interlock device.
- The facility has an area and the electronic equipment available where restricted drivers view training videos provided by the WSP or manufacturer and has a current copy of the English [WSP client training video](#) and Spanish [WSP client training video](#).
- The interlock manufacturer and/or owner of the facility agrees to allow access to a representative from the WSP to conduct an inspection at any time during scheduled business hours to ensure compliance as required in chapter 204-50 WAC.
- Valid garage keepers and operations liability insurance coverage as required in WAC 204-50-120(3).

The service center has the following **documents posted**:

- A current copy of all fees and rates a lessee may be charged for interlock services;
- When issued, a location to post the letter of certification issued by the WSP for the service center and all active technicians; and
- Hours of operation when interlock services may be obtained at the facility.
- All posted documents are plainly visible to the public and capable of being read during business hours.

The service center has adequate supplies of the following **interlock components**:

- Spare interlock devices, Camera/GPS components, wiring harnesses, and mouthpieces;
- Anti-tamper tape, toll-free phone number stickers, tamper warning stickers;
- Interlock training materials and user guides in English and Spanish;
- Secure storage area for client files; and
- Dry gas tank(s) certificate of analysis.

The service center has adequate supplies of the following [WSP forms](#) in English and Spanish:

- Installation Verification Form
- Vehicle Service Affidavit
- Non-Owned Vehicle Installation Approval
