### **PALECIRT Investigates Officer-Involved Shooting in Pullman**

**PULLMAN, Wash.** – The Palouse Area Law Enforcement Critical Incident Response Team (PALECIRT) is investigating an officer-involved shooting that occurred at a Pullman apartment complex early Thursday morning.

Pullman Police Department (PPD) officers responded to a disturbance at 1000 SE Latah St. at 8:34 p.m. Wednesday. The incident resulted in the response of the Whitman County Regional Special Weapons and Tactics (SWAT) Team, which includes officers from Whitman County Sheriff's Office (WCSSO), Pullman Police Department (PPD), and the Washington State University Police Department (WSU PD).

Officers attempted to contact an individual inside one of the apartments. Negotiations between the officers on scene and the individual appeared to include verbal communications and less lethal tools prior to the use of lethal force at 3:58 a.m.

The individual was pronounced deceased at the scene. No officers were injured during the incident.

The WSP will be the lead investigating agency in this incident. All future media communications regarding this incident will be provided through the WSP Government and Media Relations (GMR) Division in Olympia.

WSU PD will release the name of the involved officer at a later time. The Whitman County Coroner's Office will release the name of the decedent when appropriate.

Once the PALECIRT investigation is complete, the case will be forwarded to the Whitman County Prosecutor's Office for review.

*In compliance with WAC 139-12, the Washington State University Police Department personnel will not be involved in this investigation. This update is required in compliance with WAC 139-12, which mandates weekly updates be sent out by the lead investigative agency in investigations where a Washington State Peace Officer uses deadly force in the capacity of his or her law enforcement duties. These updates are required even if no new information is available at the time of the update.*

With the passage of [Washington State Initiative 940](#) in 2018, and [Substitute House Bill 1064](#) in 2019, incidents where the use of deadly force by a peace officer results in death, substantial bodily harm, or great bodily harm require an independent investigation. This investigation must be conducted in the same manner as a criminal investigation and state law now requires an “independent investigation” completely independent of the involved agency.

Per WAC 139-12, the IIT is unable to release any criminal history related to the individual, which includes the circumstances surrounding the initial contact, which prompted the law enforcement response. This information can only be released if specifically requested by the media, and is able to be released consistent with the Public Records Act Chapter 42.56 RCW.
