LICENSING AND CERTIFICATION FEE SCHEDULE

Each application has an individual billing process, which **MUST** be completed through the fee submittal form included as a part of that application. The information below is a summarization of WAC 212-80 and WAC 212-90 pertaining to the fees for licensing and certification under both RCW 18.160 and RCW 18.270.

- 1) All initial applicants for any licensing or certification pay a one-time initial application fee of \$ 100.00.
- 2) The following annual fees apply to anyone seeking licensing and/or certification:

- Licensing as Fire Protection Sprinkler System Contractor – **varies by level:**

- Certification under either RCW 18.160 or RCW 18.270 - **\$ 100.00 a year.**
 - Please note fitter certification under RCW 18.270 is a biennial program so pay for two (2) years.
 - Fitter Trainees are not charged any biennial fees.

- 3) Per RCW 18.160.050 (3), the initial annual cost for licensing and certification under that law are pro-rated for the remainder of the initial licensing/certification program (calendar) year in the following manner:

- Residential and Journey Level Fitter annual certification fees are NOT pro-rated.

- 4) The annual fees for the renewal or reinstatement of any license or certification ARE NOT pro-rated
- 5) A Late/Reinstatement Fee of \$ 100.00 is charged to reinstate any license or certification from either program, which has been expired for more than one hundred and twenty (120) days.
