- Transport the fire sprinkler trailer to your location.
- Provide a presenter/s, a sprinkler head for each demonstration, and materials.
- Operate and perform the fire sprinkler demonstrations.

*\*\*\*SFMO reserves the right to cancel event participation due to staffing availability\*\*\**

**Local jurisdictions are required to provide:**

- One person to assist with any logistical issues during the event.
- Access to demonstration area with adequate maneuvering and clearance to prevent high centering.
- Level parking area with a hard compact surface (rock, asphalt, concrete) that is large enough to accommodate a 9' x 24' trailer and pulling vehicle.
- Water supply to a garden hose connection with a minimum 35psi.
- Power connection to 120v/20 amp, **non-GFCI-protected** circuit.
