State Fire Mobilization Authorized for the Barstow Road Fire

Walla Walla County – State fire assistance has been mobilized under the Washington State Fire Services Resource Mobilization Plan in support of local firefighters working to contain the Barstow Road Fire located in Walla Walla County, near the town of Prescott. Washington State Patrol Chief John Batiste authorized the mobilization of state firefighting resources on June 22, 2025, at 9:30 p.m. at the request of Fire Chief Jim Ruffcorn, North County Fire District.

The Barstow Road Fire started on June 22, 2025, at approximately 5:43 p.m. This fire is estimated at 2,000 acres and growing. It is burning in brush and grass and is threatening crops, rangeland, and land within the Conservation Reserve Program. Level 1 evacuations are in effect at this time. The fire cause is currently under investigation.

The State Emergency Operations Center at Camp Murray is activated to Level 3, enhanced monitoring to help coordinate state assistance for the Barstow Road Fire. Mobilization specialists from the Fire Protection Bureau have ordered three strike teams and air resources to aid in containment efforts. State Fire Marshal's Office personnel are both en route to the scene and working remotely to coordinate the dispatch of resources.

Under the State Fire Services Resource Mobilization Plan, the Fire Protection Bureau coordinates the initial dispatch and continued administrative oversight of resources and personnel for the duration of the mobilization. The Mobilization Plan is implemented to provide a process to quickly notify, assemble and deploy fire service personnel, equipment and other resources from around the state when fires, disasters or other events exceed the capacity of local jurisdictions.
