## State Fire Mobilization Authorized for the Lake Spokane Fire

Stevens County – State fire assistance has been mobilized under the Washington State Fire Services Resource Mobilization Plan in support of local firefighters working to contain the Lake Spokane Fire located in Stevens County, near the city of Spokane. Washington State Patrol Chief John Batiste authorized the mobilization of state firefighting resources on July 19, 2025, at 5:30 p.m. at the request of Fire Chief Mike Bucy, Stevens County Fire District 1.

The Lake Spokane Fire started on July 19, 2025, at approximately 3:18 p.m. This fire is estimated at 350 acres and growing. It is burning in timber and brush and is threatening homes and structures. Level 1, 2, 3 evacuations are in effect at this time. The fire cause is currently under investigation.

The State Emergency Operations Center at Camp Murray is activated to Level 2, partial activation, to help coordinate state assistance for the Lake Spokane Fire. Mobilization specialists from the Fire Protection Bureau have ordered three strike teams to aid in containment efforts. State Fire Marshal's Office personnel are both en route to the scene and working remotely to coordinate the dispatch of resources.

Under the State Fire Services Resource Mobilization Plan, the Fire Protection Bureau coordinates the initial dispatch and continued administrative oversight of resources and personnel for the duration of the mobilization. The Mobilization Plan is implemented to provide a process to quickly notify, assemble and deploy fire service personnel, equipment and other resources from around the state when fires, disasters or other events exceed the capacity of local jurisdictions.
