## INTRODUCTION:

I, Trooper Brianna Jaramillo, am currently a fully commissioned State Trooper for the Washington State Patrol in Bellevue. I have been employed with the Washington State Patrol since January 10, 2014. I was commissioned May 13, 2015. I graduated and completed the Washington State Patrol Trooper Academy, the Drug Recognition Expert School, I am a Standardized Field Sobriety Test instructor, a Drug Recognition Expert instructor, and a BAC Technician.

I am currently assigned as a Breath Test Technician/Trooper in District 2, Bellevue. I have been employed with the Washington State Patrol for over eleven years. As a Breath Test Technician my responsibilities include court testimony, custodian of records for the instrument, instruction on the Draeger Alcotest 9510/PBT/SFST's, and maintenance of the instrument.
