APPOINTMENTS ARE REQUIRED FOR ALL INSPECTIONS (No walk-ins please)

Why the Inspection and What Will be Inspected?

<u>RCW 46.12.560</u> authorizes the Washington State Patrol to inspect certain vehicles for titling purposes. These inspections serve to prevent the trafficking of stolen vehicles and stolen parts.

The Vehicle Identification Number (VIN) Officer will inspect all <u>major component parts</u> used to construct your vehicle. Documentation must be presented at the time of the inspection to show legal ownership of the vehicle and parts used. Also, your vehicle must comply with all of the equipment requirements of <u>WAC Title 204</u> and <u>RCW 46.37</u> to pass inspection and for a VIN to be assigned.

What is a Recreational Vehicle?

According to <u>RCW 46.70.011</u>, a recreational vehicle is a travel trailer, motor home, truck camper, or camping trailer that is primarily designed and used as temporary living quarters, is either self-propelled or mounted on or drawn by another vehicle, is transient, is not occupied as a primary residence, and is not immobilized or permanently affixed to a mobile home lot.

What is a Motor Home?

According to RCW 46.04.305, a motor home is a motor vehicle originally designed, reconstructed, or permanently altered to provide facilities for human habitation, which include lodging and cooking or sewage disposal, and is enclosed within a solid body shell with the vehicle, but excludes a camper or like unit constructed separately and affixed to a motor vehicle.

What Parts are Required for My Vehicle to Pass Inspection?

According to RCW 46.80.010, major components parts required for titling your vehicle include:

(a) engines and short blocks; (b) frame; (c) transmission and/or transfer case; (d) cab; (e) door; (f) front or rear differential; (g) front or rear clip; (h) quarter panel; (i) truck bed or box; (j) seat; (k) hood; (l) bumper; (m) fender; and (n) airbag (airbag light must also be in working order) Catalytic converter per WAC 308-63-070.

Please note your vehicle will not pass inspection if any major component parts are damaged or missing.

What Documents are Required for a Complete Inspection?

Documents presented at the time of inspection must be printed original. **Emails, screenshots, faxes, or copies will not be accepted.**

- <u>Washington State Patrol Inspection Request</u> form completed by the licensing agent. (*The WSP will not be able to conduct an inspection without this fully completed form.*)
- Valid Picture Identification
- Weight Slip from a certified scale for the completed vehicle.
- <u>Certificates of Title or Receipts for Major Component Parts</u>. All receipts must be made out to you, the vehicle owner, your immediate family member, or the licensed shop that built your vehicle.

Major component parts purchased from a third party require a notarized bill of sale from the original purchaser to you and the original parts receipts—or, in the case of a licensed business, a letterhead statement of transfer to you and the original parts receipts. (this applies to new parts only)

Parts purchased from a **licensed business** must be presented with an original sales receipt. The receipt must show the name and address of the business, a description of the parts sold, the date of sale, and the purchase price.

Parts purchased from a **licensed vehicle wrecker** must be presented with an original sales receipt to include the wrecking yard name and address, a description of the parts sold, the date of sale, the amount of sale, and the stock number and/or VIN of the vehicle the parts came from.

Parts from a **private party** must be presented with a signed and released title, or other valid ownership documents for the vehicle from which the parts were obtained and a <u>notarized bill of sale</u>. The notarized bill of sale/gift/trade must include the name, address, phone number of the seller and purchaser, a description of the parts sold, parts vehicle information to include year, make, model, VIN, the date of sale, and the purchase price.

Parts purchased from a licensed business via the **Internet or electronically** will only be accepted for <u>new, aftermarket components</u>. You must print out a copy of the receipt to present to the VIN Officer at the time of inspection. The printed receipt must include the business name, address, phone number, date of purchase, description of part, purchase price, and tax paid. Internet bid receipts, ebay, etc. will not be accepted.

Additional Labor and Industries Requirements

According to <u>RCW 43.22.340</u> the Department of Labor and Industries (LNI) shall adopt rules governing the safety, body and frame design, and the installation of plumbing, heating, and electrical equipment in mobile homes, commercial coaches, recreational vehicles and/or park trailers. Compliance is indicated by an insigne "Sticker" as described in <u>RCW 43.22.350</u>. See <u>WAC 296-150R</u> for more information.

What If I Am Unable to Provide an Acceptable Release of Interest or Proof of Ownership?

If you are unable to provide an acceptable release of interest or proof of ownership for the vehicle or major component parts as described above, <u>RCW 46.12.560(3)</u> requires an inspection for <u>ownership-in-doubt</u> as described in <u>RCW 46.12.680</u> and <u>WAC 308-56A-210</u>. Ownership-in-doubt means applying for a three-year registration without title; after three years, a Washington title can be requested.
